### **Vigilant Aspirations: Practicing Social Mobility in Spaces of Uncertainty**

**Convenors: Eveline Dürr, Ingo Rohrer, Tim Burger**

14 November 2024, LMU Munich

This workshop explores how people aspire to and practice upward social mobility in uncertain contexts. Highlighting spaces in which complexities of belonging, economic opportunity and regimes of oppression are pronounced, we suggest that individual watchfulness is a crucial condition for ‘moving up’. Whether situated in dynamic yet policed borderlands or in ‘remote’ and deprived backwaters, aspiring actors make constant choices about how to present themselves, whom to seek intimacy with, and how to navigate the conditions of their socio-economic settings. This vigilant self-formation occurs between desired upward mobility and the operations of macro-structural processes (state policies, projects of extraction, political change etc.) and demonstrates how watchfulness is a key social practice in highly ambivalent social situations.

This workshop is situated in the Collaborative Research Center ‘Cultures of Vigilance’ (SFB 1369) which seeks to explore vigilance in its historical and cultural variations. Vigilance, here, is not so much understood through state-sponsored surveillance regimes but denotes constellations of watchfulness in which personal vigilance is related to more-than-individual goals. This lens is productive to understand aspirational strivings for ‘better lives’: we suggest that becoming vigilant about certain issues carries the potential for self-formation and upward mobility in various spaces of uncertainty. The workshop puts its ethnographic focus on questions such as: What role does vigilance play in the making of social mobility? How are individual aspirations informed by watchfulness against institutions, perceived competitors and communities? In how far are ideas about the self and ideas about community interlinked by a shared, if temporary, alertness to feasible upward mobility or structural barriers? What insights may be drawn from the interplay between hopeful aspirations, its everyday frustrations and patterns of alert social action aimed at ‘moving up’? In which specific impediments to social mobility (e.g., gendered injustice, border regimes, ecological change, state policies) is the analytic of vigilance particularly salient?
